Fair Winds to all our sailors taking part in events over the festive season and safe travels.

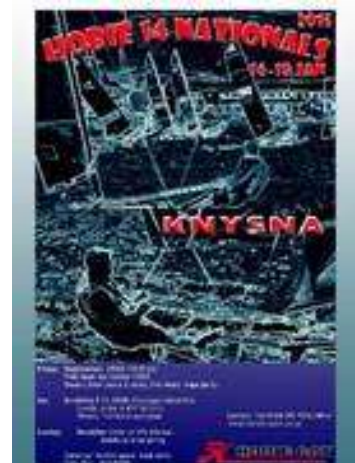
On homewaters we have sailing Regattas on the 6th & 13th with the Buffalo Bay Challenge 1 on Sunday 21st.

Boat Parking & Tenders for Unclaimed Boats/Equipment

Available space for parking of boats at the club is limited with preference given to sailors. The Boat Application forms are available from either the Restaurant or Secretary's Office. Upon handing in this application, a boat number will be issued and invoice will be raised for the cost of the sticker and the parking. Boats and/or trailers left at the club and in respect of which no Boat Parking application has been received, **will be moved to the Trailer and Boat park without further notice.**

A reminder please that any boats that remain in the grassed and shed areas at the end of December, which in the opinion of the club remain stored items, will be moved to the Trailer and Boat Park. The club accepts no liability in respect of any loss or damage to property and all items are left on KYC premises at the owner's risk.

The tender process for the abandoned boats, parts of boats and trailers, including canoes presently in the Trailer park closes on the 19th December. Offers should be submitted to KYC in a sealed envelope. **Any items not bid for will be disposed of by the club as they deem fit.** The Club reserves the right to accept or reject any offer.

Administration

After much contemplation the decision has been made to make changes to our Telephone and Internet contracts. We have installed a central PABX which improves communication to and around the club and the Internet access for Club Members is restricted to a maximum of half-hour per day per user. While at the Club coverage can also be obtained from the Waterfront and dvfree networks – these are unlimited. The process of this changeover is presently underway.

We also appeal to you all (more especially our visiting members only here for a short while) to take a look at our Photographic files from our Visiting Yachties that have been revamped and are in Asche's library – these are not to be borrowed or removed from KYC please. They are an important part of our Club history, as are the photographs which we have found and placed in a file there – please see if you can identify the persons and year's in the photo's, slip a little paper in with the photo details and we shall mark them accordingly. Please - Any other photo's you have from over the years which you could donate to the Club will be very welcome.

Financial Report

To the Members of the Knysna Yacht Club

There was a request at the AGM that the Gencom update Members from time to time on the financial affairs of your Club.

The attached table reflects the Net Income for the seven months ending October 2014 as against the Budget for the same seven months and the required Net Income for the remainder of the financial year in order to achieve the Full Year Budget.



Whilst the seven months to date do not reflect an adverse position it should be noted that:

- Bar sales have exceeded Budget by 27% and the gross margin is 4% better than forecast
- That does not indicate overcharge for any product type but a variance in product mix
- Catering sales are marginally behind budget and the gross margin at 38% is 4% behind budget. The budgeted gross and net margin may well be achieved should the last 5 months, especially the festive season, realise the sales forecast.
- Administration costs are in line with the budget for the seven months and are not likely to exceed the year budget
- Maintenance and Sailing related activities have been combined as the allocation of maintenance costs is complex. General maintenance costs have exceeded the budget to date by some R 60,000 and sailing related maintenance is R 40,000 over budget.
- As you are all aware the Club facilities are increasingly in need of expensive maintenance and these costs cannot always be delayed, as the end cost is always greater. Thus there is a risk that the full year costs for maintenance will be greater than budgeted.
- The seven months reflect a surplus of income as against costs of R 504,000; however it must be noted that receipt of subscriptions, which are more than satisfactory, is front ended in the budget. Net costs for the last 5 months of the financial year are forecast to be in the region of R 335,000 leaving little leeway for a surplus.
- The full year net income, after allowing for Debenture redemption of R 129,000 is marginal in the Budget (R 41,000) and is in all likelihood not going to be achieved.
- With this in mind the Gencom will be approaching the Debenture holders to
 - Waive the redemption of the Debentures in favour of the Club or
 - Waive the interest for this year and future periods and
 - Agree to an extended period for the redemption
- Without the support of these debenture holders your Gencom will need to cut back on operations and maintenance.
